Your letter of June 10, 2009, asked for a status update with regards to each of the above referenced dockets, along with a report on whether it is necessary to keep these dockets open. Both dockets relate to disputes between the parties which continue unresolved. Cases nearly identical to each of the cases in Tennessee have been filed and are moving towards conclusion in sister states; the Tennessee cases have not been pressed as fervently because the amounts at stake in Tennessee are relatively smaller than in other former BellSouth states.

dPi is not abandoning its claims in Tennessee in either case and is prepared to engage in a status conference and enter into a scheduling order if the TVA wishes to speed resolution of either or both of these cases.
