Dear Mr. Crocker:

CLEC applicants are required, by statute, to demonstrate their managerial, financial and technical abilities to provide the services for which they seek authority. - 2) Will Peerless Network of Tennessee, LLC provide access to 911 and E-911 emergency services, white page directory listings and directory assistance, consumer access to and support for the Tennessee Relay Center in the same manner as incumbent local exchange telephone companies, free blocking for 900/976 type services in accordance with Authority policy, Lifeline and Link-Up services to qualifying citizens of this state, and educational discounts in existence as of June 6, 1995?
- 3) Have the affiliates of Peerless Network of Tennessee, LLC been the subject of complaints filed with any federal or state agencies in the states where they are currently conducting business? If so, advise of the nature of the complaint(s) and how they were resolved.
- 4) Specify the titles of each principal officer of Peerless Network of Tennessee, LLC and state specifically what his/her duties/responsibilities will be in regard to Tennessee operations.
- 5) Provide a Sample Bill.

6) Explain more specifically, technically, how Peerless Network of Tennessee, LLC will comply with Tenn. Code Ann. § 65-21-114.

Please provide the above information by June 12, 2008. In accordance with TRA Rules, please submit either (1) thirteen written copies of your response or (2) four written copies and an electronic version and reference docket number 08-00084 on the correspondence.
