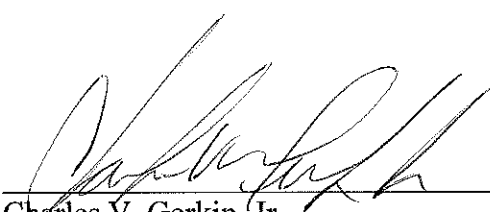
2. The undersigned desires to enter an appearance on behalf of Charter Fiberlink in the above-referenced matter.

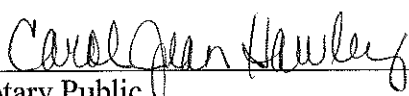
