NINTH AMENDMENT TO
CERTIFICATE OF FRANCHISE AUTHORITY

On July 1, 2008, AT&T Tennessee filed its application for a state-issued certificate of

franchise authority pursuant to the terms of the Competitive Cable and Video Services Act (the

"CCVSA"). On August 5, 2008, the Tennessee Regulatory Authority granted a Certificate of

Franchise Authority to AT&T Tennessee.

AT&T Tennessee files this ninth amendment to add the following municipalities and/or

unincorporated areas within counties to the written description, attached to its original

application, of municipalities and unincorporated areas within counties to be served in whole or

in part, by AT&T:

City of Collegedale

City of Niota.

AT&T has provided a copy of this amendment to the affected municipalities and/or

counties and will comply with all applicable notice provisions. AT&T will comply with all

requirements regarding these additional locations to the same extent as set forth in its original

application.

As required in Section (6)(c)(3) of the Act, AT&T intends to begin to offer video service

for purchase in each of the areas added above within 24 months of the date of the Authority's

acceptance of this amendment.
