

As required in Section (6)(c)(3) of the Act, AT&T intends to begin to offer video service for purchase in each of the areas added above within 24 months of the date of the Authority's acceptance of this amendment.

As required by Section 6(c)(9) of the Act, AT&T agrees to comply with the requirements set forth in the Act, expressly including the non-discrimination and service deployment requirements of Section 12 of the Act. AT&T acknowledges the provisions of Section 13 relevant to enforcement of non-discrimination and deployment requirements.

AT&T has previously submitted the required amendment fee of \$250 with this amendment, based on the population of the area designated above.


