NOTICE RESCHEDULING HEARING IN RE: Application of Memphis Light Gas and Water a Division of the City of Memphis for a Waiver with Respect to 49 CFR Part 192.7, Appendix B, and ASTM D 2513

The Tennessee Regulatory Authority (¡Authorityi) has rescheduled the public hearing in the above-captioned proceeding that was previously scheduled to commence on Monday, March 22, 2010, during the regularly scheduled Authority Conference. The public hearing will now be held during the Authority Conference, which is scheduled to beat 1:00 p.m. on Monday, May 24, 2010 in the Hearing Room on the Ground Floor at 460 James Robertson Parkway, Nashville, Tennessee. This matter will be heard by the voting panel of Chairman Sara Kyle, Director Kenneth C. Hill and Director Mary W. Freeman and will be conducted in accordance with the Tennessee Uniform Administrative Procedures Act, Tenn. Code Ann. §4-5-101 et. seq. All parties are entitled to be represented by counsel.

The Hearing is being held for the purpose of considering the request of Memphis Light Gas and Water a division of the City of Memphis (iMLGWi) for a waiver from certain Minimum Federal Safety Standards (MFSS) to permit MLGW to continue the use, in its operations, of polyethylene pipe that has an unprotected storage period in excess of two years prior to installation. Specifically, MLGW seeks a waiver from the requirements of 49 C.F.R. § 192.7, Appendix B and American Society of Testing and Materials (iASTMi) D 2513 which established certain outdoor storage limitations and safeguards with respect to polyethylene pipe used in gas distribution systems.
