Lightyear Network Solutions, LLC and Wherify Wireless, Inc. ("Petitioners") hereby provide responses to the September 16, 2008 request for information in the above-referenced proceeding.

Petitioners also filed notice of the proposed transaction in the following states: Alabama, Arizona, Arkansas, Colorado, Connecticut, Delaware, Florida, Idaho, Illinois, Iowa, Kansas, Kentucky, Louisiana, Maine, Massachusetts, Michigan, Missouri, Montana, Nebraska, Nevada, New Hampshire, New Mexico, North Carolina, North Dakota, Oklahoma, Oregon, Rhode Island, South Carolina, South Dakota, Vermont, Washington, Wisconsin, and Wyoming.

**2. Have the Petitioners filed a similar petition with the FCC? If so, list any action taken and the associated docket number. If a schedule to complete the review of your application has been established at the FCC, provide such with your response.**

Petitioners filed domestic and international Section 214 applications with the FCC on August 28, 2008, and both are currently pending. The FCC's International Bureau assigned File No. ITC-T/C-20080828-00410 to the international application. The FCC's Wireline Competition Bureau assigned WC Docket No. 08-186 to the domestic
