Dear Ms. Cooper:

Pursuant to the request of your letter of September 19, 2008, this will advise that under the present franchise agreement between the City of Sweetwater and Charter Communications there is no active PEG channel in our system.

However, the franchise agreement does provide that Charter will make such a channel available for City use upon request and demonstration of ability to broadcast and manage the system. The City began evaluation of implementing a public broadcast channel this year and once we have a good idea of start-up and maintenance costs will be asking Charter to provide such a channel for the City. I would anticipate that to be in the 2009 budget year.

Other than installation and provision of the channel, our franchise agreement does not require any payments by Charter to the City for the PEG channel.

I trust this provides the information you requested and hope the TRA will protect the interests of the City in having this means for public information available once we have terms we can afford. 

Please note that McMinn County holds a franchise agreement with Comcast Cable Communications, Inc. which provides for a PEG channel. That channel is currently active as Channel 95. McMinn County, City of Athens and the City of Etowah have a joint management agreement for operating the channel. Per the provisions of the Competitive Cable and Video Services Act, McMinn County desires to have a PEG Channel on any future franchises for cable and video services granted by the State of Tennessee to provide said services in the unincorporated areas of McMinn County.

McMinn County does not receive fees for PEG support, but has received technical and hardware assistance for the operation of the channel through our multi-jurisdictional agreement. If you need any additional information, please feel free to contact me 423.745.7634

Dear Ms. Cooper:

The current franchise agreement between Lincoln County and Charter Communications provides for one (1) video programming for public, education and government (PEG) channel. The agreement further states that Charter shall pay Lincoln County twenty-five (\$0.25) cents per cable service customer per month if the County elects to use the PEG channel.

Lincoln County has elected to delay implementing the PEG channel until further notice to Charter. We notified Charter on May 4, 2007 of this delay and informed them we would provide at least 120 days notification of any future plans to implement the aforementioned sections.



We received the OFFICIAL REQUEST for information dated September 19, 2008 and to the best of our knowledge

- (A) Cocke County has no activated PEG channels or authorized channels to be activated and,
- (B) Cocke County has no PEG support payments being provided by Charter Communications

However, we cannot establish having received a contemporaneously filed notice with Cocke County of Charter Communication's application for a state-issued certificate of franchise authority with the TRA. We have requested documentation of such filing from Charter Communications from Mr. Nick Pavlis of Charter Communications.

We are requesting notification of any further compliance filings of which we may need to be made aware which may have been included in the filing letter or other similar communications or notices by the TRA.

As a possible matter of related concern, Cocke County was entitled to receive one standard installation and free basic service to such outlet in each public school and municipal building within Cocke County under the contract which existed at January 1, 2008.
