As you are aware, Tennessee passed the Competitive Cable and Video Services Act (the "Act") during the 2008 legislative session (Tennessee Title 7, Chapter 59). This law places sole responsibility for issuing cable franchises with the TRA. Renewal of a state-issued franchise is governed by the Tennessee Competitive Cable and Video Services Act. In addition to State law, federal law also contains provisions that detail a procedure for the renewal of franchises (Section 626 of Title VI of the Communications Act of 1934, as amended (the "Cable Act")). The process under the Cable Act begins with a notice of intent to renew approximately 30 to 36 months prior to the expiration of the franchise.

Charter submits this letter to retain all applicable franchise renewal rights granted pursuant to Section 626 of the Cable Act. Charter anticipates the renewal of our franchise will occur under the Tennessee Competitive Cable and Video Services Act and we intend to meet the application and notification requirements of the Act as the date of expiration approaches.
