First Communications, LLC, Globalcom, Inc., and Renaissance Acquisition Corp. ("Petitioners") hereby provide responses to the September 30, 2008 request for information in the above-referenced proceeding.

1. Have the Petitioners filed similar petitions or notices in other states? If so, provide a listing of states and actions taken.

Petitioners requested approval for the transaction from the following states: California, Colorado, Georgia, Hawaii, Indiana, Maryland, Minnesota, Missouri, Mississippi, Nebraska, New York, New Jersey, Ohio, Pennsylvania, Tennessee, Texas, Virginia and West Virginia. All of these approval requests are pending.

Petitioners also filed notice of the proposed transaction in the following states: Alabama, Arizona, Arkansas, Connecticut, District of Columbia, Delaware, Florida, Iowa, Idaho, Illinois, Louisiana, Kansas, Kentucky, Massachusetts, Michigan, Maine, Montana, Nevada, New Hampshire, New Mexico, North Carolina, North Dakota, Oklahoma, Oregon, Rhode Island, South Carolina, South Dakota, Utah, Vermont, Washington, Wisconsin, and Wyoming.

2. Have the Petitioners filed a similar petition with the FCC? If so, list any action taken and the associated docket number. If a schedule to complete the review of your application has been established at the FCC, provide such with your response.

Petitioners filed a joint international and domestic Section 214 application with the FCC on September 26, 2008. Both domestic and international approvals are currently pending. The FCC's International Bureau assigned File Nos. ITC-T/C-20080926-0438, ITC-T/C-20080926-0439, ITC-T/C-20080926-0440 to the international application. The

3. Provide the number of customers that First Communications, LLC ("FCL") currently serves in Tennessee.


FCL has approximately 1,124 customers in Tennessee.
