Docket No. 07-00175 - Petition of First Communications, LLC and Gores FC Holdings, LLC for Transfer of Control Approval

Dear Docket Manager:

This letter hereby notifies the Authority that two transactions it previously approved will not be consummated as previously planned. Specifically:

- In Docket No. 08-00175, the Authority approved a request for a transfer of control of First Communications, LLC ("FCL") and Globalcom, Inc. ("Globalcom") to Renaissance Acquisition Corp. ("RAC"). The Authority granted approval on January 26, 2009. On behalf of FCL, Globalcom and RAC, we hereby notify the Authority that they have determined not to proceed with the proposed transaction.
- 2. In Docket No. 07-00175, the Commission approved a request for transfer of control of FCL to Gores FC Holdings, LLC ("Gores FC") in a transaction whereby Gores FC would obtain *de facto* control of First Communications, Inc. ("FCI"), the parent of FCL. The Authority granted approval on August 20, 2007. On behalf of FCL and Gores FC, we hereby notify the Authority that although Gores FC did obtain the non-controlling interest of 13.01% in FCI as described in the Petition filed with the Authority, they have determined not to complete the transfer of control approved by the Authority at this time. To the extent that they intend to do so in the future, they will file a new petition with the Authority requesting prior approval.
