


**ORDER APPROVING AMENDMENT TO THE  
STAND-ALONE INTERCONNECTION AGREEMENT**

This matter came before Chairman Tre Hargett, Director Eddie Roberson and Director Sara Kyle of the Tennessee Regulatory Authority (the "Authority"), the voting panel assigned to this docket, at a regularly scheduled Authority Conference held on November 10, 2008 to consider the Petition for approval of the Amendment to the Stand-Alone Interconnection Agreement negotiated between BellSouth Telecommunications, Inc. d/b/a AT&T Tennessee<sup>1</sup> and DeltaCom Communications, Inc. f/k/a ITC^DeltaCom Communications, Inc. d/b/a ITC^DeltaCom d/b/a Grapevine<sup>2</sup> filed on October 6, 2008.<sup>3</sup>

Based upon a review of the amendment, the record in this matter, and the standards for review set forth in 47 U.S.C. § 252, the Directors made findings consistent with those in the *Order Approving Stand-Alone Interconnection Agreement* issued on January 12, 2005 in Docket No. 04-00277 and unanimously granted the Petition.

<sup>2</sup> A name change to DeltaCom Communications, Inc. was approved by the Authority on August 23, 2006 in Docket No. 06-00192. The Petition referred to the company as ITC^DeltaCom d/b/a Grapevine.

<sup>3</sup> The original interconnection agreement was filed and approved in Docket No. 04-00277. Subsequent amendments were filed and approved in Docket Nos. 06-00035, 06-00084 and 06-00109.
