**NOTICE REGARDING KING'S CHAPEL APPEAL OF HEARING OFFICER'S
INITIAL ORDER**

Robert E. Cooper, Jr., Attorney General and Reporter for the State of Tennessee, by and through the Consumer Advocate and Protection Division of the Office of the Attorney General ("Consumer Advocate"), hereby gives notice that he does not intend to respond to King's Chapel Capacity's Motion for Expedited TRA Review of Hearing Officer's Order filed by King's Chapel Capacity on January 28, 2009.

On January 23, 2009, the Hearing Officer issued an Initial Order on Petitions for Reconsideration of the Discretionary Grant of Limited Intervention and Report and Recommendation to Separate Corollary Issues into New Docket ("Initial Order"). In that Initial Order, the Hearing Officer held that:

From this point forward, no documents are to be served by the parties or filed with the Authority that require the services of a lawyer that are also not signed by an attorney duly licensed in Tennessee. Such documents include, but are not limited to: discovery requests or answers, pre-filed testimony or responses, or legal briefs of any kind.

Initial Order at 7.

King's Chapel Capacity's motion for expedited review or, in effect, appeal of the Hearing Officer's Initial Order was not signed by an attorney. Accordingly, in light of the Hearing Officer's determination in the Initial Order, the Consumer Advocate gives notice of its intention

not to respond to the appeal by King's Chapel Capacity unless it is directed to do so by the Hearing Officer or the TRA panel of Directors.


