MOTION FOR ONE DAY EXTENSION


Tennessee Wastewater Systems, Inc. ("TWS") requests an extension of one day, from February 9, 2009, to February 10, 2009, to file a response to the "Motion for Appeal" filed by King's Chapel Capacity on January 28, 2009, in the above-captioned docket. Counsel for TWS is participating in a pre-hearing conference at the TRA on February 9, 2009, in another TRA docket (Docket 08-00219, CenturyTel and Embarq). The flurry of recent filings in that docket and counsel's preparation for the pre-hearing conference have necessitated this request.

This one-day extension will not affect any other parties or the deliberations of the TRA. The TRA Staff and the Consumer Advocate Division have indicated to the TRA (and confirmed to counsel for TWS) that they do not intend to file responses to the "Motion for Appeal" unless otherwise directed by the TRA. See CAD filing of January 29, 2009, and Staff filing of January 27, 2009. King's Chapel will also not be affected by the one-day delay since the "Notice of Filing" issued by the TRA General Counsel on January 29, 2008, does not provide for any reply from King's Chapel. Similarly, this one-day delay will not affect the deliberations of the TRA since the next, regularly scheduled TRA agenda conference is not until February 23, 2009.

For these reasons, TWS asks that this one-day extension be granted.


