PETITION TO UTILIZE ASSUMED NAME

Globalcom, Inc. ("Applicant" or "Company"), by its attorneys, pursuant to Section 1220-4-1-.08 hereby respectfully requests that the Tennessee Regulatory Authority ("TRA"), approve the Company's use of the assumed name "First Communications".

Upon approval of the use of the assumed name, the Company will amend the title page of its tariff on file with the Tennessee Regulatory Authority accordingly.

The Company further submits the following:

- 1. On October 10, 2008 the TRA issued an Order in Docket No. 08-00139 granting the Joint Petition of Globalcom, Inc. and First Communications, Inc. for Approval of the Indirect Transfer of Control of Globalcom, Inc. to First Communications, Inc., and shortly thereafter the transfer was consummated.
- 1. On October 17, 2008, pursuant to T.C.A. § 48-14-103, the Company filed an Application for Registration of Assumed Corporate Name with the Tennessee Secretary of State to use the assumed name "First Communications" for purposes of aligning the Company's identity more closely with that of its parent company, First Communications, Inc. A file-stamped copy of the application and the accompanying filing acknowledgement from the Secretary of State is attached hereto as Exhibit A.

- 2. The Company has amended its Surety Bond No. K07674090 obtained pursuant to T.C.A. § 64-4-125 in favor of the State of Tennessee with Westchester Fire Insurance Company to reflect usage of the assumed name. The Rider to Bond is attached hereto as Exhibit B.
- 3. The Company notified customers by utilizing a bill insert in its October billing cycle. A copy of the notification is attached as Exhibit C. The assumed name will be used on a going forward basis, rather than on a service specific basis.

Wherefore, Globalcom, Inc. respectfully requests that the TRA authorize the utilization of the assumed name "First Communications" so that the Applicant may proceed with business under that name without undue delay.
