ORDER GRANTING MOTION OF GREENEVILLE SEWAGE LLC TO PERMIT SUBSTITUTE TESTIMONY AND TO PERMIT ALLEN JOHNSON TO APPEAR TELEPHONICALLY AT THE HEARING

This matter came before the Hearing Officer upon the Motion of Greeneville Sewage LLC to Permit Substitute Testimony and to Permit Allen Johnson to Appear Telephonically at the Hearing ("Motion") filed on behalf of Greeneville Sewage LLC ("Greeneville") on April 9, 2009. The Motion requests permission to substitute the Testimony of Allen Johnson, as attached to the Motion, for the Pre-Filed Testimony of Allen Johnson submitted with the Petition to Transfer the Certificate of Public Convenience and Necessity of HC Sewage Treatment, LLC to Greeneville Oil and Petroleum, Inc. (the "Petition"). Additionally, the Motion requests permission for Allen Johnson to appear and participate telephonically at the hearing on the merits of the Petition scheduled on April 14, 2009 at 2:00 p.m. CST.

Tenn. Code Ann § 4-5-312 (c) (2004) addresses electronic participation at a hearing as follows:

(c) In the discretion of the administrative judge or hearing officer and agency members and by agreement of the parties, all or part of the hearing may be conducted by telephone, television or other electronic means, if each participant in the hearing has an opportunity to participate in, to hear, and, if technically feasible, to see the entire proceedings while taking place.

In its *Motion*, Greeneville states that significant expenses have been incurred to accomplish the transfer. In an effort to avoid additional expenses and lessen scheduling conflicts, Greenville submits its request for telephonic appearance of its corporate representative and witness, Allen Johnson. In accordance with the above-referenced statute and considering that Greenville has made its request in a timely manner, the Hearing Officer finds the *Motion* well-taken and hereby grants Greeneville's requests for substitution of testimony, and for telephonic appearance of Allen Johnson in the Hearing noted above, conditioned upon the following:

- 1. Greeneville is solely responsible for, and shall be required to, secure a properly licensed Notary Public in good standing in the State or jurisdiction where the testimony is to be given, and who will physically appear with Allen Johnson, corporate representative and witness, who at the Hearing will be called telephonically to give live testimony or to ratify testimony previously filed with the Tennessee Regulatory Authority.
- 2. The Notary Public secured by Greeneville, as noted above, shall be duly authorized to administer the Testimonial Oath, and shall do so during the Hearing and remain physically present with Allen Johnson at all times during his testimony and until such time as he is excused from examination by the Hearing Officer.
- 3. Following the conclusion of the Hearing, the Notary Public shall prepare and sign an Affidavit, affirming the proven identity of the witness, Allen Johnson, the fact that such person was sworn by the Notary Public, and that the testimony given by the sworn witness was in accordance with the highest ethical and legal standards as observed by the Notary Public. The Affidavit shall bear the official seal of the signing Notary Public, and the testifying witness, Allen Johnson, shall also be required to sign a conforming Witness Certification. (As a courtesy, sample forms of the *Witness Certification and Notary Public Affidavit* are attached hereto as Exhibit A.)

4. The original Notary Public Affidavit and the original Witness Certification

described above shall be post-marked within five (5) days of the Hearing and received by the

Hearing Officer via postage-paid U.S. Mail. In the event that both a Notary Public Affidavit and

Witness Certification properly containing the affirmations noted above fails to be produced to

the Hearing Officer as set forth herein, the testimony of the witness may be struck from the

record and may constitute grounds sufficient for denial of the petition.

IT IS THEREFORE ORDERED THAT:

1. The Testimony of Allen Johnson, as attached to the Motion of Greeneville Sewage

LLC to Permit Substitute Testimony and to Permit Allen Johnson to Appear Telephonically at the

Hearing, is substituted for the Pre-Filed Testimony of Allen Johnson previously submitted with

the Petition to Transfer the Certificate of Public Convenience and Necessity of HC Sewage

Treatment, LLC to Greeneville Oil and Petroleum, Inc.

2. Mr. Allen Johnson, corporate representative and witness, of Greeneville Sewage

LLC may, subject to the conditions set forth in this Order, appear and participate telephonically

in the Hearing on the merits scheduled on April 14, 2009 at 2:00 p.m. CST by calling (615) 532-

7746 in advance of the commencement time set for the Hearing. The Hearing will start promptly

at the aforementioned time.
