AFFIDAVIT OF GARY A. MCDONALD

I, Gary A. McDonald, under penalty of perjury and being duly sworn, state the following:

I am Vice President of Cable One, Inc., a Delaware corporation.

Cable One, Inc. holds a state-issued certificate of franchise authority in Tennessee for the provision of cable and video service. The certificate was originally issued on February 23, 2009 and was recently reissued on January 7, 2019 under Docket No. 08-00228.

The entity now named Cable One, Inc. intends to conduct business in the State of Tennessee, and throughout its operations nationwide, under the assumed corporate name of Sparklight.
