ORDER GRANTING PETITION FOR RECONSIDERATION

This matter came before Director Eddie Roberson and Director Kenneth C. Hill of the Tennessee Regulatory Authority (the "Authority" or "TRA"), members of the voting panel¹ assigned to this docket, at the regularly scheduled Authority Conference held on April 26, 2010, for consideration of the *Petition for Reconsideration* ("Petition") filed by Everycall Communications, Inc. d/b/a Local USA d/b/a All American Home Phone ("Everycall" or "Company") on April 13, 2009. The *Petition* sought reconsideration of the Authority's March 30, 2010 *Order Denying Designation as an Eligible Telecommunications Carrier* ("Order").

The Company states that in support of its *Petition*:

Everycall will present additional new evidence to demonstrate that it will advertise the availability of the services supported by the federal universal service support mechanisms in areas where it is currently providing service in Tennessee. Everycall will present evidence that it will accept responsibility as a carrier of last resort if it were designated as an ETC.² Everycall will present new evidence in the form of new documents for its proposed tariff and data responses.

Everycall provided with its *Petition* a copy of its revised tariff that was submitted after the Authority's February 22, 2010 hearing (the hearing at which the ETC designation was first denied). Everycall also states in its *Petition* that its Interconnection Agreement with BellSouth d/b/a AT&T of Tennessee which had not been approved at the time of the February 22, 2010 hearing, has now been filed and has been assigned Docket No. 10-00019.


During the regularly scheduled Authority Conference held on April 26, 2010, the Directors voted to grant Everycall's *Petition* and to address the merits of the reconsideration at a future conference. The Directors noted that granting the *Petition* does not imply that the March 30, 2010 *Order* is reversed.

IT IS THEREFORE ORDERED THAT:


