MOTION FOR STAY

Everycall Communications, Inc. ("Everycall") hereby moves the Tennessee Regulatory Authority ("Authority") for a stay of the proceedings in this case. As grounds for its motion, Everycall states the following:

1. On July 12, 2010, Everycall filed a voluntary petition for bankruptcy under Chapter 11 of Title 11, United States Bankruptcy Court for the Middle District of Louisiana. Notice of Bankruptcy filing is attached.
2. A stay of certain actions under 11 U.S.C. § 362(a) may prohibit Everycall and the Authority from proceeding with the administrative case.
3. Even if the Authority action is not prohibited, a stay is necessary to determine the status of Everycall after the termination of the bankruptcy proceeding.
4. A stay is in the interests of judicial economy and efficiency since, among other factors, there is no necessity for designation as an Eligible Telecommunications Carrier until Everycall's post-bankruptcy status is determined.

WHEREFORE, Everycall respectfully requests that its Motion be granted.
