Pursuant to the request of Jerry Kettles of the Tennessee Regulatory Authority staff, Charter Fiberlink - Tennessee, LLC ("Charter Fiberlink") hereby provides the following responses to Data Request No. 1 in connection with the above-referenced Petition for Financing Approval. The numbered paragraphs below correspond to the individual data requests.


Petition for Financing Approval from any federal agency.
