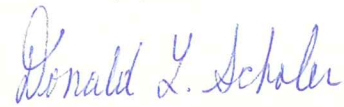

PUBLIC NOTICE

All members of the public please take notice that on March 5, 2009, Lynwood Utility Corporation filed a Petition to change and increase its rates and charges for sewer service with the Tennessee Regulatory Authority. The sewer rate changes and increases have been proposed because the utility's existing rates do not produce sufficient revenue to

permit the utility to meet its operating expenses and earn a reasonable rate of return on its investment in utility plant which are necessary for the utility to operate its sewer system in accordance with all requirements of the Tennessee Regulatory Authority and the Tennessee Department of Environment and Conservation. The public hearing date for the Petition has been set for 9:00 a.m. on Friday, August 21, 2009 and will be heard in the Tennessee Regulatory Authority's Hearing Room at 460 James Robertson Parkway, Nashville, Tennessee. The proposed rate revisions are set forth as follows:

Monthly Sewer Service Rate - Residential - The utility proposes to increase the residential monthly sewer service rate from \$6.53 per 1,000 gallons of flow per month as measured by water usage to \$8.78 per 1,000 gallons of flow per month as measured by water usage. The utility proposes to increase the minimum monthly bill for a residential customer from \$15.00 to \$20.00. These rate changes will result in an increase in the average residential customer's monthly bill from \$35.92 to \$48.92 (excluding the sewer surcharge).

Monthly Sewer Service Rate - Non-Residential - The utility proposes to increase the non-residential monthly sewer service rate from \$8.16 per 1,000 gallons of flow per month as measured by water usage to \$10.41 per 1,000 gallons of flow per month as measured by water usage. The utility proposes to increase the non-residential minimum monthly bill from \$20.00 to \$30.00. These rate changes will result in an increase in the average non-residential customer's monthly bill from \$816.00 to \$1,041.00 (excluding the sewer surcharge).

Tap Fees - The utility proposes to increase the residential tap fee from \$3,500 to \$4,500, and the utility proposes to increase the non-residential tap fee from \$7.86 per gallon per day to \$10.41 per gallon per day (computed by multiplying the peak monthly usage during the first 12 months by 365 days).

Sewer Connection Fee - The utility proposes to increase the sewer connection fee from \$250 to \$350.

Return Check Fee - The utility proposes to increase the returned check charge from \$20.00 to \$30.00.

A complete copy of the proposed tariff changes and the reasons for them are on file with the Tennessee Regulatory Authority and are open to public inspection.
