We understand that on March 30th, 2010, a complaint was reported to the Consumer Services Division regarding odor. Although Lynwood has not received any direct complaints with respect to odor during this time period, we acknowledge this complaint and are taking active measures.

As of April 2010, Cottonwood HOA Liaison, Jimmy Prittchett (representing 484 of Lynwood's customers within the subdivision) has now received his first complaint that appears to be the same odor event as this referenced complaint. Jimmy Prittchett is continuing to work with the Cottonwood homeowners to help them understand that the first call should be made to Lynwood at 615.790.3632. Any complaint filed through the HOA should answer specific questions found in the attached document. These questions help us determine the most likely source of the odor and what measures to take to assist in the reduction of that odor.

Since September 2009, Lynwood has made significant investments in both manpower and financial resources to attempt to reduce the amount of odor coming from its WWTP and Collection System pump stations.

Lynwood is maximizing its odor control capabilities with respect to manpower, equipment, and chemicals (given that it is economically feasible). During this seasonal climate change, increasing odor control chemicals and decreasing sludge retention time may assist in the reduction of odor.

The information we will be requesting on any odor event is listed as follows:

- 1. Name
- 2. Address of resident
- 3. Time of the call
- 4. Duration of odor problem
- 5. Phone number
- 6. Location where odor detected
- 7. Level of severity

We have created a system by which to clarify the severity of the odor event.

Level 1 0 to 5 minutes
Level 2 6 minutes to 1 hour

Level 3 over 1 hour

By defining these different levels it will help us determine the most likely cause of the odor so we will be able to address the issue more efficiently.
