Dear Chairman Kyle:

I am writing to you in follow up to my letter to you dated July 22, 2009, in which I set forth Lynwood Utility Corporation's written responses to clarifying questions asked by the Authority Staff at the status conference in this docket on July 1, 2009.

The response to the first question in my July 22, 2009 letter failed to state the period of time over which the TDEC-Regulatory Cost is being amortized. I have set forth below the amended response to this first question:

1. Explain the amortization of TDEC-Regulatory Cost and over what period of time this amount is being amortized.


Answer: The amortization of TDEC-Regulatory Cost is the amortization of the \$75,895.00 in attorney fees and litigation expenses incurred by Lynwood Utility Corporation to defend the enforcement action by TDEC against the Company which was settled by a Consent Order and Dismissal in 2004 entered by the Davidson County Chancery Court. The TDEC-Regulatory Cost is being amortized over a five year period.
