# ORDER REQUIRING HEALTHCARE ADVANTAGE LLC/ THE SELECT GROUP/ CHRIS WIGGINS TO APPEAR AND SHOW CAUSE WHY A CEASE AND DESIST ORDER AND/OR FINE SHOULD NOT BE IMPOSED

This matter is before the Hearing Officer on the recommendation of the Consumer Services Division ("CSD") of the Tennessee Regulatory Authority (the "Authority" or "TRA"), pursuant to Tenn. Code Ann. § 65-4-501, to consider preliminary findings of the CSD against Healthcare Advantage LLC ("Healthcare Advantage"), The Select Group ("Select") and Chris Wiggins ("Mr. Wiggins") (collectively, "Respondents") and determine whether to require the Respondents to appear before the Hearing Officer and show cause why the Authority should not sanction the Respondents for alleged violations of Tenn. Code Ann. §§ 65-4-501 through 506.

## **JURISDICTION**

Tenn. Code Ann. § 65-4-504(a) (2004) provides:

The Authority is authorized to initiate proceedings . . . . to: issue a cease and desist order; to issue an order imposing a civil penalty up to a maximum of two thousand dollars (\$2,000) for each knowing violation; and to seek additional relief in any court of competent jurisdiction.

### ALLEGED VIOLATIONS OF THE "DO NOT FAX" LAW

T.C.A. § 65-4-502(a)(Supp. 2008) provides:

No person shall transmit or cause another person to transmit an unsolicited facsimile advertisement;

Beginning August 28, 2006 through July 11, 2008, the Authority, through its Consumer Services and External Affairs Division, received 130 complaints from Tennessee telephone subscribers alleging that the Respondents had knowingly transmitted or caused unsolicited facsimile advertisements to be transmitted to them.

Shuptrine, CSD's notices of violation and the response thereto are attached hereto as collective Exhibit 125).

**COUNT 125:** On 6/24/2008, the Respondents knowingly sent or caused an unsolicited facsimile advertisement to be sent to fax number belonging to Phyllis W. Shuptrine who objects to receiving unsolicited facsimile advertisements in violation of Tenn. Code Ann. § 65-4-502(a).

126. Micaela A. Fisher of filed a complaint (F08-0595) with the CSD on 7/1/2008 alleging that the Respondents sent an unsolicited facsimile advertisement to telephone number on 5/22/2008. The CSD sent an Official Notice of Alleged Violation to the Respondents via certified mail on 7/21/2008 and 7/30/2008. (The complaint of Micaela A. Fisher, CSD's notices of violation and the response thereto are attached hereto as collective Exhibit 126).

**COUNT 126:** On 5/22/2008, the Respondents knowingly sent or caused an unsolicited facsimile advertisement to be sent to fax number belonging to Micaela A. Fisher who objects to receiving unsolicited facsimile advertisements in violation of Tenn. Code Ann. § 65-4-502(a).

127. Micaela A. Fisher of filed a complaint (F08-0596) with the CSD on 7/1/2008 alleging that the Respondents sent an unsolicited facsimile advertisement to telephone number on 6/24/2008. The CSD sent an Official Notice of Alleged Violation to the Respondents via certified mail on 7/21/2008 and 7/30/2008. (The complaint of Micaela A. Fisher, CSD's notices of violation and the response thereto are attached hereto as collective Exhibit 127).

**COUNT 127:** On 6/24/2008, the Respondents knowingly sent or caused an unsolicited facsimile advertisement to be sent to fax number belonging to Micaela A. Fisher who objects to receiving unsolicited facsimile advertisements in violation of Tenn. Code Ann. § 65-4-502(a).

128. Douglas L. Stevick of Texas RioGrande Legal Aid, Inc. at 311 Plus Park Blvd., Suite 135, Nashville, Tennessee 37217 filed a complaint (F08-0601) with the CSD on 7/2/2008 alleging that the Respondents sent an unsolicited facsimile advertisement to telephone number (615) 366-3349 on 6/30/2008. The CSD sent an Official Notice of Alleged Violation to the Respondents via certified mail on 7/21/2008 and 7/30/2008. (The complaint of Texas RioGrande Legal Aid, Inc., CSD's notices of violation and the response thereto are attached hereto as collective Exhibit 128).

**COUNT 128:** On 6/30/2008, the Respondents knowingly sent or caused an unsolicited facsimile advertisement to be sent to fax number (615) 366-3349 belonging to Texas RioGrande Legal Aid, Inc. which objects to receiving unsolicited facsimile advertisements in violation of Tenn. Code Ann. § 65-4-502(a).

129. Mary S. Harmon of filed a complaint (F08-0608) with the CSD on 7/9/2008 alleging that the Respondents sent unsolicited facsimile advertisements to telephone number on 7/1/2008. The CSD sent an Official Notice of Alleged Violation to the Respondents via certified mail on 7/21/2008 and 7/30/2008. (The complaint of Mary S. Harmon, CSD's notices of violation and the response thereto are attached hereto as collective Exhibit 129). Additional unsolicited facsimile advertisements were received on 1/8/08, 3/11/08, 3/19/08, 3/31/08, 4/22/08, 4/30/08, 5/15/08, and 5/23/08.

**COUNT 129:** On 7/1/2008, the Respondents knowingly sent or caused an unsolicited facsimile advertisement to be sent to fax number belonging to Mary S. Harmon who objects to receiving unsolicited facsimile advertisements in violation of Tenn. Code Ann. § 65-4-502(a).

130. Randall A. Davis of filed a complaint (F08-0617) with the CSD on 7/14/2008 alleging that the Respondents sent an unsolicited facsimile advertisement to telephone number on 7/11/2008. The CSD sent an Official Notice of Alleged Violation to the Respondents via certified mail on 7/21/2008 and 7/30/2008. (The

complaint of Randall A. Davis, CSD's notices of violation and the response thereto are attached hereto as collective Exhibit 130).

**COUNT 130:** On 7/11/2008, the Respondents knowingly sent or caused an unsolicited facsimile advertisement to be sent to fax number belonging to Randall A. Davis who objects to receiving unsolicited facsimile advertisements in violation of Tenn. Code Ann. § 65-4-502(a).

### **CONCLUSION**

The CSD received a total of 130 complaints from 69 consumers.<sup>1</sup> These consumers state that these faxes are unsolicited and they have no existing business relationship with the Respondents. In some cases, consumers state that the opt-out numbers provided by the Respondents appear to be used as confirmation for fax numbers to be sold to other advertisers. Requests from consumers for their fax numbers to be removed from further solicitation were unheeded. The Respondents simply continued to cause to transmit these unsolicited facsimile advertisements and the CSD continued to receive complaints.

On June 10, 2008, the CSD issued a subpoena to the carrier, Advanced Communications for telephone number (800) 881-0436, which was the originating facsimile number for these complaints. Advanced Communications customers have prepaid toll accounts. On June 10, 2008, Advanced Communications responded that the referenced facsimile number is paid for by a credit card in the name of Paul Wilson of P.O. Box 61633, Charleston, South Carolina. Advanced Communications also produced 139 pages of calls originating from (800) 881-0436 that are forwarded to (843) 225-1685, which belongs to a different carrier, Knology. On June 12, 2008, a subpoena for telephone number (843) 225-1685 was issued to Knology. On June 18, 2008, the CSD received a response from Knology which identified the number as belonging to Healthcare Advantage at 2055 Spaulding,

North Charleston, South Carolina 29406 and supplied a user name of Healthcareadvantage and an email address of Lawrence@selectcompany. On June 18, 2008, an attorney, George R. Katosic, called CSD staff on behalf of his client, Healthcare Advantage, LLC, and stated that his client does not send faxes into the State of Tennessee. On June 23, 2008, the CSD faxed all Notices of Alleged Violation to Healthcare Advantage, LLC at (843) 225-9042. On July 3, 2008, the CSD received a letter dated June 30, 2008 from Mr. Katosic stating that his law office acts as compliance counsel to Healthcare Advantage, LLC, which denies responsibility for the offending faxes, and further directed the CSD to investigate a different company. After the exchange of several letters, e-mails and information between CSD Staff and the law office of George R. Katosic, CSD Staff determined that Healthcare Advantage, LLC and/or its affiliate, The Select Company, is responsible for causing the transmission of the unsolicited facsimile advertisements that are the subject of these complaints. By letter of July 28, 2008, Mr. Katosic formally responded to all 130 Notices of Alleged Violation on behalf of both The Select Company and Healthcare Advantage, LLC and admitted that a marketing entity, Global Promoting, had sent the prohibited facsimiles as part of a marketing campaign. The CSD then sent all Notices of Alleged Violation to Global Promoting, which were subsequently returned to sender. The whereabouts of Global Promoting could not be determined despite additional investigation by the CSD. Nevertheless, the Respondents are liable for the acts of their agent, as follows.

### **SUMMARY OF CHARGES**

Tenn. Code Ann. § 65-4-502(a) provides:

No person shall transmit or cause another to transmit an unsolicited facsimile advertisement.

CSD's investigation discloses that the Respondents have followed a pattern of continued violation of Tenn. Code Ann. § 65-4-504(a). Tenn. Code Ann. § 65-4-504(a) provides:

The Authority is authorized to initiate proceedings relative to a violation of this part or any rules and regulations promulgated

pursuant to this part. Such proceedings include, without limitation, proceedings to: issue a cease and desist order; issue an order imposing a civil penalty up to a maximum of two thousand dollars (\$2,000) for each violation; and to seek additional relief in any court of competent jurisdiction. Violations shall be calculated in a liberal manner to deter violators and to protect consumers. Each page of each unsolicited facsimile advertisement may constitute a separate violation . . . .

Additionally, the Respondents have also not complied with Tenn. Code Ann § 65-4-502(b) which provides:

Any transmission by facsimile shall include in a margin at the bottom of each transmitted page or on the first page of the transmission the date and time of the transmission; an identification of the business, other entity or individual sending the message; and the telephone number of the sending machine of such business, other entity or individual.

The number of consumer complaints alleging violations in this Show Cause petition totals one hundred thirty (130). As a result, the maximum monetary penalty that may be assessed against Respondent for the alleged violations of Tennessee Do-Not-Fax Law included in this order is Two hundred sixty thousand dollars (\$260,000.00).

**BASED UPON THE FOREGOING**, the Hearing Officer hereby determines that the Respondents should appear and show cause why the Authority should not issue a cease and desist order and impose a civil penalty upon the Respondents of up to \$2,000 for each violation of Tenn. Code Ann. § 65-4-502(a) (2004).

#### IT IS THEREFORE ORDERED THAT:

1. Healthcare Advantage LLC, The Select Group and Chris Wiggins<sup>3</sup> shall respond within **thirty (30) days** of the issuance of this Order.

2. The Respondents shall appear before the Authority, on a date yet to be determined, to show cause why the Authority should not proceed to take action against Healthcare Advantage LLC,

The Select Group and Chris Wiggins for the unlawful actions set forth in this Order, including, but not limited to, the issuance of a cease and desist order and the imposition of a civil penalty up to a maximum of two thousand dollars (\$2000.00) for each violation.
