1. On November 23, 2009, the Hearing Officer granted the Petitioner's *Motion of Petitioner for Extension of Time to Respond to Chris Wiggins' Motion to Dismiss and the Response of Healthcare Advantage LLC and the Select Group to Show Cause Order of October 9, 2009* extending the time to respond until December 11, 2009.

2. The parties have reached a settlement in principal, and expect to file a proposed Settlement Agreement within three weeks.

4. If the Directors reject the agreement, the parties request that the proceeding recommence 14 days from the date of the Directors' action.


Premises considered, Petitioner and Respondents move to hold proceeding in abeyance pending action by the Directors on a Settlement Agreement.


