PETITION FOR APPROVAL

Comes now Lynwood Utility Corporation (Lynwood) and files this Petition for approval of an additional \$250,000 loan to refinance its existing working capital line of credit pursuant to T.C.A. § 65-4-109. In support of its Petition, Lynwood states as follows:

- 1. Lynwood Utility Corporation provides sewer service in Williamson County, Tennessee, pursuant to a certificate of public convenience and necessity issued originally to Lynwood Utility Company on June 14, 1976. Lynwood provides sewer service to approximately 830 customers within its certificated service area.
- 2. Lynwood obtained a commitment dated December 7, 2007, from Tennessee Commerce Bank (the Bank) to loan Lynwood an amount not in excess of \$1,000,000 to refinance Lynwood's existing Note to Tenn. Contractors, Inc. and for a \$250,000 working capital line of credit for \$250,000. The term of the \$1,000,000 loan is five years with an interest rate of 7.5% fixed for five years. Principal and interest payments are based upon a fifteen year amortization. The Authority approved this \$1,000,000 loan and the short-term \$250,000 working capital line of credit on February 19, 2008 in Docket No. 07-00263.
- 3. Lynwood obtained another commitment dated March 13, 2009, from the Bank to increase its loan to Lynwood by \$250,000, bringing the total loan to an amount to \$1,250,000.

The terms of the additional \$250,000 loan is that same as the original loan with an interest rate of

7.5% fixed for the duration of the term. Principal and interest payments are based upon a fifteen

year amortization. The Bank's letter approving the additional loan amount is attached hereto as

Exhibit 1.

4. Lynwood's interest rate on the additional \$250,000 loan is the same as the interest

rate of the existing \$1,000,000 loan. Therefore, the grant of this Petition will not change

Lynwood's cost of capital in providing sewer service to its customers, nor will it change its

annual cash requirement.

WHEREFORE, PREMISES CONSIDERED, PETITIONER PRAYS THAT THE

AUTHORITY:

1. Approve the additional \$250,000 loan from Tennessee Commerce Bank pursuant

to T.C.A. § 65-4-109.

2. Have such other relief to which it may be entitled.
