

1. The application contained a printout from the Tennessee Secretary of State's Office regarding the status of America Internet Sales Group, Inc. Please provide a copy of the actual certification letter sent to the company by the Secretary of State's Office.

ANSWER: See attached.

2. The application states that America Internet Sales Group, Inc. is not providing service in Tennessee or any other state at this time; however, the Profit and Loss Statements for the period January through December 2008 indicates Sales, Cost of Good Sold, Gross Profit and Net Income. From what source were these funds derived?

ANSWER: We are not providing regulated service in TN at this time. We are providing Consulting and Internet services.

3. Provide a current Balance Sheet for ASIG.

ANSWER: See attached.

4. The management information section of the application contains information on only one office of the company. Are there other officers or staff? If so, provide background information, including education and relevant telecommunications experience, for each officer. (no other officers for AISG at this time)

ANSWER: Currently, Scott Raymer is the only officer of America Internet Sales Group, Inc.

5. Does the company have a Chief Financial Officer? If so, provide detailed background information for this individual.

ANSWER: Scott Raymer is CFO.

6. Who will the company rely on for technical support?

ANSWER: The company has contracted technicians for technical support as well as well as Scott Raymer.

7. Mr. Raymer's resume indicates he is also President and Owner of Integrated Communication Consulting Services, Inc., which has a "sales force of 3 telecommunications agents." Will these agents be selling America Internet Sales Group, Inc.'s long distance services? What sales methods will be used? Will these agents conduct telemarketing sales? If so, is the company familiar and does the company agree to comply with Tenn. Code Ann. § 65-4-401, *et seq.*?

ANSWER: Yes ICCS will be one of the many independent agents used to deliver sales for America Internet Sales Group, Inc. Methods of sales: (marketing to produce inside sales calls, cold calling with independent contractors to sell services.) AISG does not sell to residential customers, only businesses. AISG will not perform telemarketing sales.

WHEREAS, AISG, INC. (the "Principal"), has applied to the Tennessee Regulatory Authority for authority to provide telecommunications services in the State of Tennessee; and

WHEREAS, under the provisions of Title 65, Chapter 4, Section 125(j) of the Tennessee Code Annotated, as amended, the Principal is required to file this bond in order to obtain such authority and to secure the payment of any monetary sanction imposed in any enforcement proceeding brought under Title 65 of the Tennessee Code Annotated or the Consumer Telemarketing Act of 1990 by or on behalf of the Tennessee Regulatory Authority (the "TRA"); and

WHEREAS, INTERNATIONAL FIDELITY INSURANCE COMPANY (the "Surety"), a corporation licensed to do business in the State of Tennessee and duly authorized by the Tennessee Commissioner of Insurance to engage in the surety business in this state pursuant to Title 56, Chapter 2 of the Tennessee Code Annotated, has agreed to issue this bond in order to permit the Principal to comply with the provisions of Title 65, Chapter 4, Section 125(j) of the Tennessee Code Annotated;

Regardless of the number of years this bond may remain in force, the liability of the Surety shall not be cumulative, and the aggregate liability of the Surety for any and all claims, suits or actions under this bond shall not exceed Twenty Thousand Dollars (\$20,000.00). 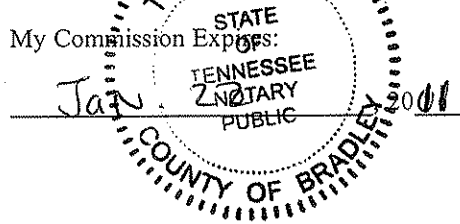



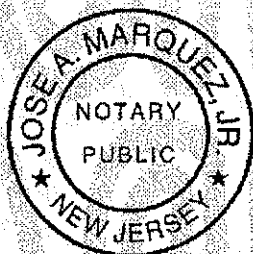
