To Whom It May Concern:

This letter is to advise that America Internet Sales Group is non-compliant with Tenn. Code Ann. § 65-4-125(j) and § 65-4-301. These statutes require authorized telecommunications providers in Tennessee to provide a \$20,000 Surety Bond or Letter of Credit and to pay Annual Inspection Fees to the Tennessee Public Utility Commission.

Our records indicate American Internet Sales Group has not paid Annual Inspection Fees for the years 2013, 2016, 2017 or 2018. We have also received a Cancellation Notice from International Fidelity Insurance Company for bond number BUIFSU0500512, issued on behalf of America Internet Sales Group, to be effective May 1, 2019. A copy of the bond Cancellation Notice is attached.

In its original application for authority to provide telecommunications services in Tennessee, (Docket No. 09-00049), the President of the company, Scott Raymer, affirmed that the company would "comply with the Reseller Rules and all other applicable Authority Rules and state laws..." A copy of the Rule Compliance Agreement section of the Resale Application and notarized signature of Mr. Raymer is attached.

Due to its non-compliance with the aforementioned statutes, the authority to provide telecommunications services in Tennessee granted to America Internet Sales Group will be considered for cancellation at the May 2019 Conference of the Tennessee Public Utility Commission.

To avoid cancellation of America Internet Sales Group's authority in Tennessee, the company must comply with the Annual Inspection Fee requirement, including payment of applicable late fees, as well as maintaining its Surety Bond.
