Dear Chairman Roberson,

This letter is the response of Worldspice Communications, Inc. to the Information Request of May 7, 2009 concerning the above Petition. I appear to have transposed company names of "Worldspice" and "Webnet" in my mind when drafting the first line of Section III, paragraph 2 "Types of Local Exchange Services To Be Provided" in the Petition. The phrase "*Applicant currently plans to continue providing VoIP services...*" is incorrect and should read "*Applicant plans to provide VoIP services...*" Your applicant, Worldspice Communications, Inc., has not been and is not currently "doing business" of any kind, anywhere.

1. Yes, as a CLEC Worldspice will provide white pages directory listing, access to 911 emergency services, free blocking for any 900/976 calls, access to the telecommunications relay center, Lifeline and Linkup to qualifying individuals, and educational discounts existing on June 6, 1995, either by obtaining these services from a contract provider or in-house upon turn up of its own switching equipment.
2. The sentence in question should state, "If a customer dials 0, the call will be routed to a Worldspice-provided local operator service". (Webnet is not a certified Operated Services Provider.)
3. The fax number for TRA notifications is 901-843-9301; Blake Weber's email address is blake@worldspice.net and for Paul Tomes is ptomes@worldspice.net.
4. Worldspice Communications, Inc. does not currently engage in business in or outside of Tennessee.
5. A corporate resolution of WebNet Memphis, Inc., authorizing unsecured loans to WorldSpice Communications, Inc. up to \$250,000 is attached


6. Webnet (not Worldspice) has offered VoIP since 2006 in the Memphis area.

7. Webnet (not Worldspice) currently offers VoIP service through a joint venture with a CLEC. The Letter of Agency used in the business identifies Aeneas Communications, LLC and authorizes Aeneas to act as Customer's agent for the selected service changes.

Applicant plans to provide VoIP voice services through a joint venture with a CLEC, and by this application, seeks authority to provide resold and facilities-based interexchange and local "telecommunications services" to the public statewide by initially reselling services obtained from and utilizing facilities leased from facilities-based carriers and eventually providing telecommunications services via facilities constructed, owned, leased, or managed, by Applicant.

I hope this is responsive to your questions and I apologize as some of the confusion came from my pen. If you need further information we will be glad to respond.


