**ORDER RESUSPENDING TARIFF AND PROPOSED RATE INCREASE
AND MODIFYING PROCEDURAL SCHEDULE**

By Order of the Tennessee Regulatory Authority ("Authority") of June 4, 2009, the revised tariff and proposed rate increase was suspended through August 29, 2009. Due to the procedural schedule proposed by the parties and adopted at the Status Conference of July 1, 2009, a hearing in this matter is not scheduled to be convened prior to the suspension date. As such, the revised tariff and proposed rate increase is re-suspended through October 28, 2009.


At the July 1, 2009 Status Conference, a procedural schedule, proposed by the Consumer Advocate and Protection Division of the Office of the Attorney General ("Consumer Advocate") and agreed to by Cartwright Creek, LLC ("Cartwright Creek"), was approved subject to modification by the Hearing Officer. On July 24, 2009, Cartwright Creek requested a seven (7) day extension to respond to the Consumer Advocate's First Discovery Request, which was agreed to by the Consumer Advocate and approved by the Hearing Officer. On August 11, 2009, the Consumer Advocate requested a seven (7) day extension to file its Direct Testimony, and cited the previous agreement of the parties and approval of the Hearing Officer; such testimony was timely filed on August 24, 2009. Also on August 24, 2009, a *Petition to Intervene* was filed

by Waterbridge Development, Inc. ("Waterbridge"). By Authority Rule 1220-1-2-.06(2), Cartwright Creek has seven (7) days to file its response to the requested intervention of Waterbridge. Therefore, the remaining procedural schedule is as follows:

August 31, 2009	Cartwright Creek's response to Waterbridge's Petition to Intervene
September 8, 2009	Cartwright Creek's Rebuttal Testimony
September 9, 2009	Status/Pre-Hearing Conference (to be set by notice)
September 21, 2009	Hearing on the merits (tentative/to be set by panel and notice)
October 5, 2009	Post-Hearing Briefs
October 28, 2009	Six months from filing of rate case.

IT IS THEREFORE ORDERED THAT:

The revised tariff and proposed rate increase is re-suspended through October 28, 2009.
The Procedural Schedule as set forth above is hereby adopted.
