MOTION

At the Status Conference held on June 3, 2009 in the above referenced Docket, Kentucky Utilities Company ("KU") made an oral motion requesting the Tennessee Regulatory Authority ("TRA") to waive TRA Rule 1220-4-1-.05 to the extent that it requires KU to publish, in a newspaper of general circulation located in the utility's service area, a notice and a summary of the proposed changes in rates and the reasons for them. In lieu of such newspaper publication, KU requested that it be allowed to notify its five Tennessee customers directly with: (1) a letter sent by first class U.S. mail containing the information required in TRA Rule 1220-4-1-.05 and giving the date, time and place of the hearing and (2) a letter enclosed with each customer's bill including the same notice contained in the separate letter. The Hearing Officer, Gary Hotvedt, granted the motion.

Subsequently, the Hearing Officer requested that the motion be submitted in writing. In anticipation of sending out the notices in the customers' bills prior to the hearing, KU determined that the meters of the Tennessee customers are scheduled to be read on or about June 23, 2009. The hearing is scheduled for June 29. KU is concerned that if notices are placed in the envelopes with the June invoices, the notices may not reach the customers prior to the hearing. Therefore as set forth in the following motion, KU modifies its motion made at the status conference to

provide one notice to the customers by mail, instead of two notices. Thus, the following motion is made.

Pursuant to TRA Rule 1220-1-1-.05¹, KU moves that the TRA waive TRA Rule 1220-4-1-.05 to the extent that it requires KU to provide notice of the proposed rate changes, reasons for the changes and notice of the hearing to be published in a newspaper of general circulation located in the KU service area in Tennessee. In lieu of such newspaper notification, KU requests that it be allowed to provide the information required by TRA Rule 1220-4-1-.05 to customers by providing such notice in a letter addressed to each customer by first class U.S. mail. KU requests such alternative form of notice because it believes that direct notice would be more effective in actually reaching its five Tennessee customers, than newspaper notice. The customers affected live in Fork Ridge, Tennessee. To the best of KU's knowledge and belief, the newspaper of general circulation that is nearest to KU's Tennessee service area is the Middlesboro Daily News in Middlesboro, Kentucky. In addition to being more effective notice to the customers, such direct notice will be more cost effective for KU.

For good cause shown, KU respectfully requests that the TRA grant the relief requested in this Motion.
