A CUSTOMER BASE TRANSFER

IDS Telcom Corp. ("IDS"), Now Communications, Inc. ("NOW") (IDS and NOW together, the "Sellers") and Birch Telecom of the South, Inc. d/b/a Birch Communications of the Southeast ("Birch") (IDS, NOW and Birch collectively, the "Petitioners") respectfully request, pursuant to Rule 1220-4-2-.56 of the Tennessee Regulatory Authority ("TRA") Rules, the TRA to approve on an expedited basis the transfer of customers from Sellers to Birch. Upon approval of this petition, the Petitioners propose to transfer approximately 160 business customers, 32 residential customers and 95 prepaid local service customers in Tennessee from Sellers to Birch.

IDS and NOW are each Delaware corporations. Sellers are wholly owned subsidiaries of Cleartel Communications, Inc. ("CCI"), a Delaware corporation and leading provider of voice and data solutions serving customers in the Northeast, Southeast, Southwest, and Midwestern United States. Sellers have principal offices at 1960 S. Congress Ave., Suite 201, Delray Beach, Florida 33445. CCI, through Sellers and its other subsidiaries, offers local, Internet and long distance services to both residential and business users in 30 states. In Tennessee, IDS and NOW hold the following authorizations:

<u>IDS</u> holds local exchange and interexchange authority granted in Docket No. 05-00048. <u>NOW</u> holds local exchange and interexchange authority granted in Docket No. 03-00455.

Upon completion of the Transaction and the migration of customers to Birch, Sellers will no longer offer telecommunications services in Tennessee. After Sellers determine that they no longer need their authorizations for operational or billing purposes, Sellers will surrender their authorizations in a separate filing.

In Tennessee, the Birch companies consist of the following, Birch Telecom of the South, Inc. d/b/a Birch Communications of the Southeast, a wholly owned subsidiary of Birch Communications, Inc. and Birch Communications, Inc. (formerly known as Access Integrated Networks, Inc. d/b/a Birch Communications) ("BCI"). BCI is a Georgia corporation with principal corporate offices located at 4885 Riverside Drive, Suite 304, Macon, Georgia 31210. Birch is one of the largest competitive local exchange carriers in the Southeast, Southwest and Midwest regions serving small and medium business customers. Birch deploys its own private IP network utilizing soft switch technology to deliver innovative, high quality, affordable voice and broadband communications services to small and medium business customers. BCI and/or its subsidiaries are authorized to provide telecommunications services in thirty (30) states, with certification pending in two additional states. BCI and/or its subsidiaries are also authorized to provide interstate and international telecommunications services. Birch was granted authority to provide resold local exchange and long distance services in Tennessee by order issued July 20, 2000 in Docket No. 00-00341.

After the necessary regulatory approvals and satisfaction of other closing conditions, the aforementioned customers will be served by Birch. Upon completion of the customer transfer, Birch will resolve any customer questions that may result from the transfer.

Prior to implementing these changes, notification will be sent by Petitioners, using envelopes and letterhead bearing the appropriate logo of Sellers or CCI, to all affected customers. This notification will advise the customers of the following: the pending change of their carrier selection to Birch; that there will be no change to the rates, terms, and conditions of the service(s) to be provided by the acquiring carrier without sufficient notices as identified herein; that there will be no charge to the customer associated with the change; that the subscriber has the right to select a different preferred carrier; a toll-free customer service telephone numbers for inquiries about the transfer; the fact that all subscribers receiving the notice, including those who have arranged preferred carrier freezes through their local service providers, will be transferred to the new carrier if they do not select a different preferred carrier before the transfer date; and who Customers should contact regarding questions or complaints before and after the transfer is completed. Birch agrees to provide the affected customers a thirty day written notice of any rate increase that may affect their service up to ninety

Petitioners respectfully request that the TRA issue an order pursuant to Rule 1220-4-2-.56 permitting Petitioners to consummate the customer base transfer. In support of this request, Petitioners provide the following information:

I. DESCRIPTION OF THE PETITIONERS

Sellers and Birch are authorized to provide local and long distance services in Tennessee. These companies offer a competitive variety of local and interexchange telecommunications services. These companies are authorized to provide telecommunications and related services in other states either pursuant to certification or registration, or on an unregulated basis. These companies are also authorized by the FCC to provide interstate and international telecommunications services.

III. REQUEST FOR APPROVAL

Pursuant to Rule 1220-4-2-.56 of the Tennessee Regulatory Authority Rules, the telecommunications provider of a customer shall not be changed without the customer's authorization. Rule 1220-4-2-.56(2)(d) provides that in the case of a transfer of a customer base between two or more telecommunications providers, the Authority, upon petition by the acquiring provider may deem that sufficient notice has been given and grant approval of the petition. The Petitioners have complied with Federal Communications Commission ("FCC") notice requirements for a waiver of the authorization and verification rules for implementation of the subscriber carrier selection changes provisions of the Telecommunications Act of 1996. (Attachment 1) Further, the Petitioners have drafted proposed subscriber notification letters in compliance with Federal and Tennessee law (Attachment 2).

IV. CUSTOMER IMPACT

This transaction will be made in a seamless fashion that will avoid disruption to consumers. Following closing, virtually all Customers will continue to receive service at substantially the same rates, terms and conditions that they currently receive from Sellers. There may be instances, however, where there are service or rate structure dissimilarities that Birch cannot accommodate with its existing systems (e.g., customers currently utilizing a message or measured local service plan). In those cases, Birch will transition customers in as neutral a manner as is reasonably possible, with no increase to the regular monthly recurring charges, and will notify those customers of their new rates, terms and conditions of service. As a result, the proposed transaction will be almost transparent to customers in terms of the rates and terms and conditions of service that most of these customers currently receive. There will be no interruption of service, other than a minor change to the non-regulated voicemail, which must be reset. Customers will be well informed of their choices.

V. PUBLIC INTEREST CONSIDERATIONS

The proposed transaction will ensure that the Customers enjoy continuity of high-quality telecommunications service. As discussed above, Customers will be given prior written notice of the transfer of their account to Birch, in compliance with the customer base transfer requirements of the FCC and the TRA. Following the transaction, the Customers will continue to receive services which will be consistent with the quality of services currently provided by Sellers and which will be supported by Birch's experienced and well-qualified management team. As a result, the proposed transaction will be almost transparent to most customers in terms of the rates and terms and conditions of service that these customers currently receive.

If prior customer authorization were to be required in this event, customers may fail to respond to a request for authorization, neglect to select another long distance carrier or lose their long distance service during the transition. Consequently, granting this Petition is consistent with the public interest by maintaining continuity of customers' services and by promoting local and interexchange competition among telecommunications carriers in Tennessee. Further, by granting this Petition, unnecessary slamming complaints will be prevented during the transition, saving Petitioners and the TRA administrative burdens.

WHEREFORE, for reason stated above, the Petitioners submit that the public interest, convenience and necessity would be furthered by a grant of this Joint Petition for Approval of a Customer Base Transfer pursuant to Rule 1220-4-2-.56(2)(d).
