

Question No. 1 Provide a fax number for Broadvox-CLEC, LLC.

Question No. 2 The audited financial statements provided for Broadvox, Inc. and Subsidiaries did not include financial information for Broadvox-CLEC, LLC. Does the applicant have financial statements? If so, please provide a current Balance Sheet, Income Statement and Statement of Cash Flows.

Response: Broadvox-CLEC, LLC does not have stand alone financials.

Question No. 4 Provide more specific information regarding previous positions held by the Broadvox-CLEC, LLC management team, including duties and responsibilities and what aspects of Tennessee operations each will oversee.

Response: Jeff Slater, the new President of Applicant, was Director of Product Development from 1990 to 1992 for LCI International. Mr. Slater was the Executive Vice President of TotalTel USA, Inc. from 1994 to 1998. Mr. Slater was President of Cedar Valley Communications from 2005 to 2007, and was Vice President of Strategic Planning for CIMCO Communications from 2007 to 2008. Finally, Mr. Slater was the Founder and President of JTek Systems, Ltd. from 1999 to 2004 which provided telecommunications consulting services to carriers. Mr. Slater is responsible for network planning,

network implementation, bill verification, and other back office functions.

Andre Temnorod, Chairman & CEO of Broadvox, brings more than 12 years of executive management experience to Broadvox. Prior to founding Broadvox, Mr. Temnorod served as the CEO of Nexbell Communications, a VoIP provider. Nexbell was purchased by COUNSEL Communications in 2001. Mr. Temnorod next served as Chief Technology Officer at Unicent Technologies, a large privately held communications company, where he led the research and deployment testing of early VoIP initiatives.

Mr. Temnorod is responsible for overall planning and execution of the company's business plan.

Eugene Blumin, COO of Broadvox, has more than 15 years of experience in technology field. Prior to Broadvox, Mr. Blumin was co-founder of Nexbel Communications and served there as Director of Carrier Relations. Prior to Nexbel, Mr. Blumin served as President and COO of Unicent Technologies.

Mr. Blumin is responsible for billing and accounting,

Alex Gertsburg, Vice President and General Counsel, and head of Broadvox's Tennessee operations, graduated magna cum laude from the Cleveland Marshall College of Law and was honored with membership in the Order of Barristers as a result of his tenure in the school's moot court program. During law school, he also served as an extern for the late Judge John Manos of the US District Court for the Northern District of Ohio. He received his BA from Miami University in 1996, after studying political science and sociology.

Mr. Gertsburg currently handles and supervises all of Broadvox's legal work. Prior to joining Broadvox, his primary legal focus was business litigation with the corporate firms of Calfee, Haller & Griswold LLP in Cleveland, and Roetzel & Andress LPA in Akron. In both firms, he worked closely-held, publicly-traded and foreign clients in developing strategies to resolve complex and diverse legal disputes, both inside and

outside the courtroom. He also handled First Amendment, antitrust, real estate and commercial disputes. In heading up Broadvox's Tennessee operations, Mr. Gertsburg will draw not only on his own and Mr. Temnorod's and Mr. Blumin's telecommunications experience, but will also benefit from the knowledge and experience of Broadvox's underlying carriers.

maintain operations as a telecommunications provider in Tennessee.


