

"[L]eave shall be freely given when justice so requires." At this time, no substantive proceedings have yet occurred, only the filing of the parties' claims and answers. Therefore, allowing the filing of this amended complaint will not prejudice any party. Under T.R.C.P. Rule 15.01 and TRA Rule 1220-1-2-.03(i), the respondent has thirty days to file an answer to the amended complaint.


