### REQUESTED INFORMATION

#### 1. Amount of Support the Company Received for the Past Fiscal Year

For the Fiscal 2008, the Company received the following amounts of support for each of the available High Cost Mechanisms for study Area Code 299007; \$0 for High Cost Model, \$0 for High Cost Loop Support, \$0 for Safety Net Additive Support, \$0 for Safety Valve Support, a \$251.00 for Intrastate Access Support, \$0 for Local Switching Support, and \$0 for Interstate Common Line Support.

#### 2. How the Those Funds Were Allocated

The funds that were allocated for Interstate Access Support (IAS) is available to competitive carriers operating in the service areas of price-cap Incumbent carriers and designated as ETCs by the state commission or FCC. IAS helps to offset interstate access charges in order to reduce the cost of long distance charges incurred by end users and is targeted to zones with low customer density. Both AT&T of Tennessee and Budget are eligible to receive IAS on serving lines in areas where the companies are unable to recover permitted revenues from newly revised subscriber line charge.

# THE COMPANY RESPECTFULLY SUBMITS THAT IT MEETS THE QUALIFICATIONS FOR CONTINUNED CERTIFICATION FOR STUDY CODE 299007

The Company respectfully submits that, given the number and nature of the requirements for support already in place, the Commission may lawfully and appropriately rely upon these self-certifications by the Company. The requirements, procedures, and processes to which the Company adheres, as set forth above, provide the necessary and sufficient basis for the Commission to provide its certification to USAC and the FCC, and to thereby ensure that the Company and its customers will not be deprived of the USF funding to which the Company and its customers are lawfully entitled to possess. Essentially, under the existing rules and process discussed above, the federal support funds received by the Company and other ETCs are, in fact, and integral part of the recovery of expenditures incurred in the provision, maintenance, and upgrading of its provision of universal services. The processes described above constitute the Company's

plan with respect to the receipt and utilization of federal universal support, upon which the Company depends to provide its customers with quality telephone service at competitive prices. Furthermore, the Company attests, per the above certification, that it is using federal universal support for its intended purpose.

In many respects, the certification process is similar to the certification process, which the Commission uses in its initial designation of eligible telecommunication carriers, thereby fulfilling its right, as established by the Telecommunications Act of 1996, to designate a carrier as an ETC.

The very same procedure and process undertaken by Commission that is valid for designation of eligibility to received funds is also rationally valid as the basis for the necessary certification that the Company will use those funds, once received, for the purposes for which they are intended.
