THIRD AMENDMENT TO CERTIFICATE OF FRANCHISE AUTHORITY

On September 15, 2009, Comcast Cable Communications Management, LLC (hereinafter, "Comcast") filed its application for a state-issued Certificate of Franchise Authority pursuant to Tenn. Code Ann. § 7-59-301, et seq., also known as the Competitive Cable and Video Services Act of 2008, (hereinafter, the "Act"). Such Certificate of Franchise Authority was granted to Comcast by the Tennessee Regulatory Authority on October 2, 2009.

On August 10, 2010, Comcast filed its First Amendment to its Certificate of Franchise Authority to supplement certain municipalities and/or unincorporated areas within Counties to those previously described within its application filed September 15, 2009. Such First Amended Certificate of Franchise Authority was granted to Comcast by the Tennessee Regulatory Authority on September 23, 2010.

On March 29, 2011, Comcast filed its Second Amendment to its Certificate of Franchise

Authority to effectuate an intercompany transfer of the Certificate in Docket No. 09-00024 into Docket

No. 09-00137 and add certain municipalities and/or unincorporated areas within Counties to those

previously described within its application filed September 15, 2009. Such Second Amended Certificate

of Franchise Authority was granted to Comcast by the Tennessee Regulatory Authority on April 19, 2011.

Comcast hereby files this Third Amendment to its Certificate of Franchise Authority to add the

following municipalities and unincorporated areas within counties to the written description, attached

to its original application, of municipalities and unincorporated areas within Counties to be served in

whole or in part by Comcast pursuant to such Certificate, as amended:

Germantown, Tennessee

Comcast has provided a copy of this Amendment to Germantown, Tennessee, and will comply

with all applicable notice provisions.

Based on the population of the areas designated above, Comcast has submitted the required fee

of two hundred fifty dollars (\$250.00) with this Amendment.


