**AMENDMENT TO**  
**CERTIFICATE OF FRANCHISE AUTHORITY**

On September 15, 2009, Comcast Cable Communications Management, LLC (hereinafter, "Comcast") filed its application for a state-issued Certificate of Franchise Authority pursuant to the terms of the Competitive Cable and Video Services Act (hereinafter, the "Act"). Such Certificate of Franchise Authority was granted to Comcast by the Tennessee Regulatory Authority on October 2, 2009.

Comcast files this Amendment to add the following municipalities and unincorporated County area to the written description, attached to its original application, of municipalities and unincorporated areas within Counties to be served in whole or in part by Comcast:

- City of Waverly, Tennessee
- City of Soddy Daisy, Tennessee
- Humphreys County, Tennessee

Comcast has provided a copy of this Amendment to the affected municipalities and County listed above and will comply with all applicable notice provisions. Comcast will comply with all

requirements regarding these additional locations to the same extent as set forth in its original application.

Comcast's affiliates, Comcast of Nashville I, LLC, and Comcast of the South, are incumbent cable service providers as defined in Section 4(13) of the Act and are currently providing cable service to the respective service areas listed in Exhibit A, herein.

As required by Section 6(c)(9) of the Act, Comcast agrees to comply with the requirements set forth in the Act, expressly including the non-discrimination and service deployment requirements of Section 12 of the Act. Comcast acknowledges the provisions of Section 13 of the Act relative to the enforcement of non-discrimination and deployment requirements.

Based on the population of the areas designated above as provided for in Section 6(b)(2) of the Act, Comcast has submitted the required fee of two hundred fifty dollars (\$250.00) with this Amendment.

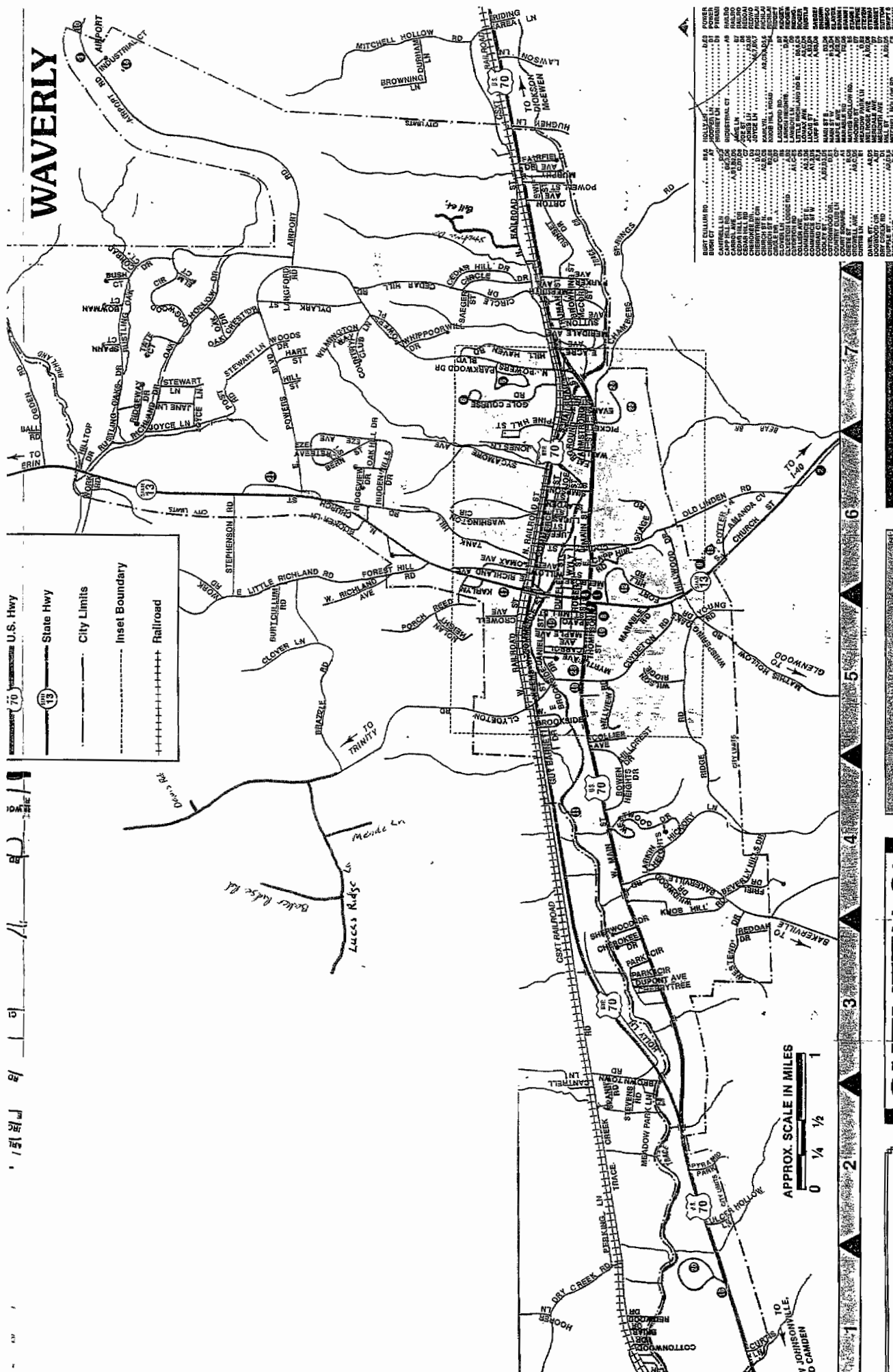

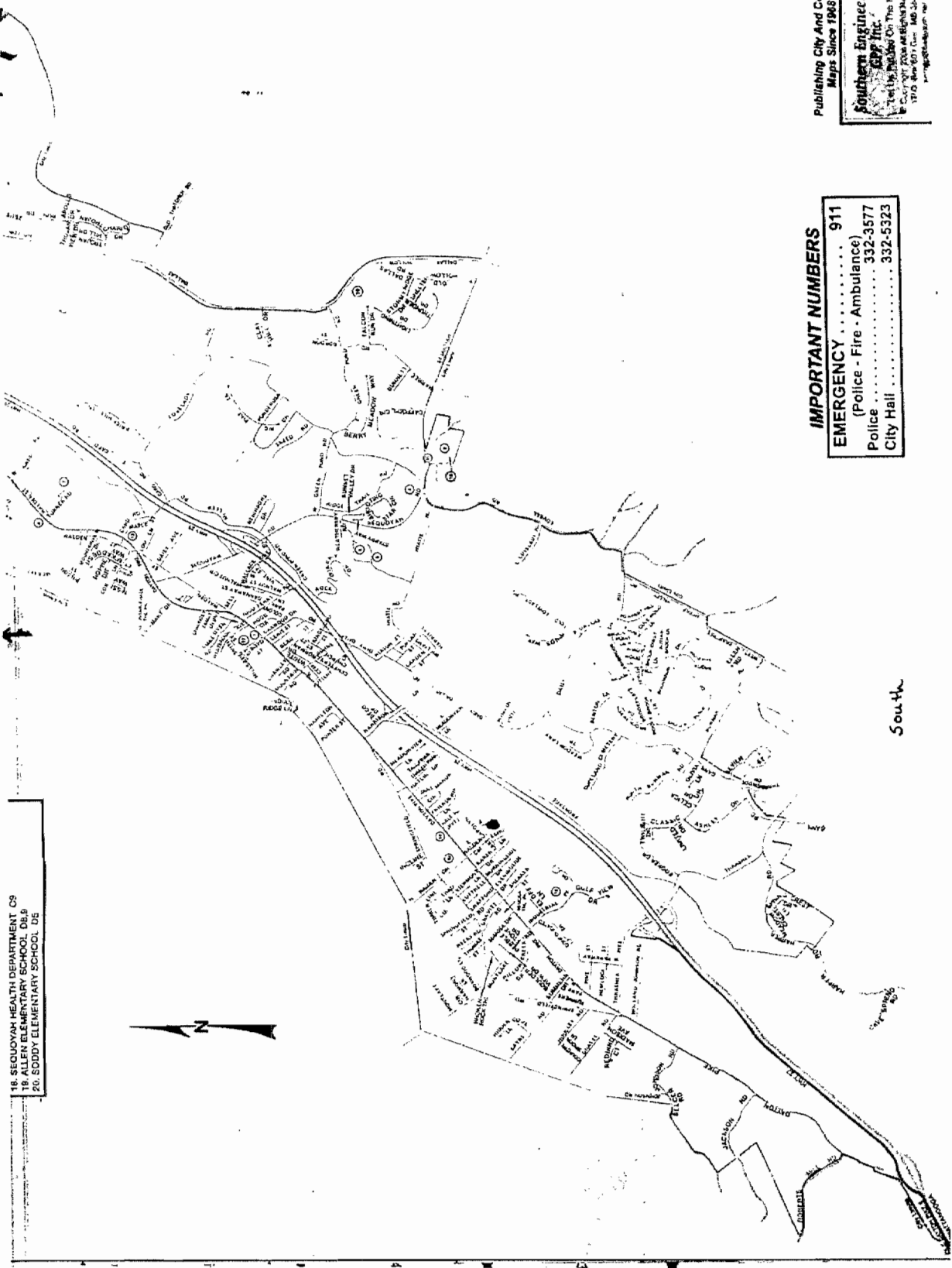
