SECOND AMENDED CERTIFICATE OF FRANCHISE AUTHORITY

On March 29, 2011, pursuant to Tenn. Code Ann. § 7-59-301, *et seq.*, also known as the Competitive Cable and Video Services Act (the "CCVSA"), Comcast Cable Communications Management, LLC, on behalf of its affiliates operating in Tennessee,¹ ("Comcast"), filed with the Tennessee Regulatory Authority ("TRA") its *Second Amendment to Certificate of Franchise Authority* to supplement certain municipalities and/or unincorporated areas within counties² to those areas previously described within its application filed September 15, 2009. Comcast also sought to effectuate an intercompany transfer of the Certificate in Docket No. 09-00024³ to this docket.⁴ As no basis for denial of the amendment under Tenn. Code Ann. § 7-59-305(i)(1) of the CCVSA has been alleged, the TRA hereby issues this Amended Certificate of Franchise Authority to supplement the original the Certificate of Franchise Authority issued to Comcast on October 2, 2009.
