Answer:

Yes, NobelTel filed similar applications in the following states: California, Hawaii, Minnesota, Mississippi, New York, Ohio, Pennsylvania and West Virginia. These applications currently are pending. NobelTel filed similar notices in the following states: Alabama, Arizona, Arkansas, Connecticut, Delaware, Georgia, Idaho, Illinois, Indiana, Iowa, Kansas, Kentucky, Louisiana, Maine, Maryland, Massachusetts, Michigan, Missouri, Montana, Nebraska, Nevada, New Hampshire, New Mexico, North Dakota, Oregon, Rhode Island, South Carolina, South Dakota, Vermont, Wisconsin and Wyoming. No further action will be taken in these notice states.

Have the applicants filed a similar application with the FCC? If so, list any action taken and the associated docket number. If a schedule to complete the review of your application has been established by the FCC, provide such with your response.

Answer: Yes, NobelTel filed a similar petition with the FCC on October 27, 2009. The FCC issued public notice of the domestic transfer application on November 2, 2009, WC Docket No. 09-198. Automatic approval of the domestic transfer application is expected to be on December 3, 2009. The FCC has not yet issued public notice of the international transfer application.

3) Provide the number of customers that NobelTel currently serves in Tennessee.

Answer:

NobelTel does not maintain intrastate subscriber information beyond revenue information because of the nature of the calling card market and the fact that services are provided primarily on a wholesale basis. The vast majority of the end users served make interstate or international calls. Indeed, NobelTel's Tennessee intrastate operations are quite small. From January 1, 2009 through October 31, 2009, NobelTel recorded 307 intrastate calls and approximately \$42 of intrastate revenues.

4) Provide a copy of NobelTel's Stock Purchase Agreement dated October 26, 2009, which governs the change in ownership transaction.
