The Tennessee Rural Coalition¹ (Coalition) respectfully submits the following comments regarding protective orders to govern the exchange of Confidential Information in Tennessee Regulatory Authority (TRA) dockets. The Coalition represents 11 rural local exchange carriers (ILECs) providing service in Tennessee.

Pursuant to the Notice issued by Hearing Officer Hotvedt in Docket No. 09-00183, the Coalition has reviewed and considered the Consumer Advocate's Submission and proposed protective order. Upon careful consideration, the Coalition submits this letter in support of the Comments and Proposed Protective Order filed by Piedmont Natural Gas, Inc. in this docket. The Coalition respectfully submits that the Proposed Protective Order being offered as Exhibit A to Piedmont Natural Gas, Inc.'s Comments captures the necessary protections and procedural safeguards that should be afforded to all entities proceeding before the TRA.
