Chattanooga Gas Company ("CGC") has discovered that a portion of its response to Minimum Filing Guideline ("MFG") 25 contains confidential information that was inadvertently produced without being labeled as Confidential. The sheet titled "Rate Case Cost – FG 69-4" of the excel spreadsheet file titled "CGC TRA FG Item 25 – Cost of Service and Rate Base.xls" contains an itemization of outside consultants' costs which is confidential commercially sensitive information.



Behind tab no. 25 in the notebook, please replace the original hard copy response for MFG 25 dated 11/13/09 and the CD titled "Chattanooga Gas Company Docket No. \_\_ TRA MFG 25" with the enclosed revised hard copy response dated 1/28/2010 and the new CD titled "Chattanooga Gas Company Docket No. 09-00183 TRA MFG 25 (Redacted 1-28-2010)". This revised CD contains all of the information and excel spreadsheets that were provided on the original CD, except that the confidential information contained in the "Rate Case Cost – FG 69-4" sheet of the excel spreadsheet file titled "CGC TRA FG Item 25 – Cost of Service and Rate Base.xls" has been redacted. Another CD titled "CONFIDENTIAL CGC Docket 09-00183 Portion of MFG 25 – Rate Case Cost – FG 69-4" contains the unredacted version of the confidential "Rate Case Cost – FG 69-4" sheet, and is being provided under seal.

As requested, the TRA Staff additionally received four CDs labeled "MFG's Full Set Filing 11-16-09". Upon being granted intervention, the CMA received a copy of this CD on December 18, 2009. Please replace the original CD with the enclosed new CD labeled "MFG's Full Set (Non-Confidential) (Redacted 1-28-2010)". Additionally, as explained above, the second new CD contains a copy of the confidential portion of MFG 25.

Once you have made the replacements, CGC requests that you either return to me the original CDs and all copies that you have made (including any hard copies) or certify in writing that you have destroyed them. CGC additionally requests that you obtain and either return to me or certify that you have destroyed any copies of the original CDs that you have provided to any outside consultants and/or any designated individuals as allowed pursuant to paragraph 3 of CGC's Proposed Protective Order.
