J.W.,

I hope this email finds you doing well. I am writing with regard to your recently filed Application to Appear Pro Hac Vice, filed on behalf of Kenneth T. Maloney. After reviewing this application, it came to my attention that there were two issues with his application.

First, Rule 19(d) requires that "a certificate of good standing from the court of last resort of the licensing jurisdiction in which the lawyer principally practices" be included with the applying attorney's affidavit.

Furthermore, Rule 19(f) requires that:

At or before the time the lawyer files a motion for admission and supporting papers under this Rule with the court before which the lawyer seeks admission, the lawyer shall file with the Board of Professional Responsibility of the Supreme Court of Tennessee a copy of the motion and supporting papers filed under this Rule and shall pay to the Board a fee in an amount the total of which equals the fees required of Tennessee lawyers under Tennessee Supreme Court Rule 9, Section 20.1, Tennessee Supreme Court Rule 25, Section 2.01, and Tennessee Supreme Court Rule 33.01 C.

There is no indication from your filing that Mr. Maloney has provided the required Certificate of Good Standing or paid the requisite fees to the Tennessee Board of Professional Responsibility. If you can remedy these two issues prior to Mr. Maloney's appearance, I believe this should take care of any issues with this application. Thank you for your time and I hope that this will avoid any unnecessary argument or inconvenience between the parties.

If for some reason this cannot be taken care of prior to Mr. Maloney's appearance, as required by Supreme Court Rule 19, please let me know immediately so that we can inform the Hearing Officer and Henry Walker that it may be necessary to begin prior to 10 a.m., in order to deal with these preliminary matters.

Thanks again and I look forward to hearing from you. Please feel free to contact me should you have any questions (I believe this is the last matter that we should need to discuss prior to Monday's hearing, but feel free to contact me if you have anything further).
