Response to Request 1. The 3.03 reports as filed by Chattanooga Gas Company for the twelve month period, June 1, 2010 through May 31, 2011 and June 1, 2011 through May 31, 2012 are provided on CD-ROM. The 3.03 report for the twelve month period ending May 31, 2013, however, has yet to be filed and is not due until July 31, 2013. In the alternative, enclosed is the most recent 3.03 report received for CGC (March 31, 2013).
