Chattanooga Gas Company ("CGC" or "Company") files this proposed Procedural Schedule along with its Petition for Approval of Adjustment of its Rates and Charges, Modification of its Rate Design, and Revised Tariff for consideration in this matter.

If the TRA decides to convene a contested case and appoint the general counsel or his designee as hearing officer, CGC respectfully requests that the hearing officer convene a status conference at the hearing officer's earliest convenience. CGC is available for a status conference on Monday, December 14, 2009, immediately following the regularly scheduled TRA Conference. Alternatively, CGC requests that the hearing officer enter an order ruling on any motions to intervene, establishing a procedure for entering the proposed protective order which is being filed contemporaneously herewith¹, and entering a procedural schedule. CGC recommends the following procedural deadlines for the hearing officer's consideration.

¹ The proposed protective order filed by CGC is the same protective order that the parties submitted by agreement in CGC's last rate case (TRA Docket 06-00175) except for the addition of the following four words on page 3: "or the Producing Party's customers".
