Consistent with the *Joint Motion on Procedural Issues* the parties submitted in these dockets on May 20, 2010, the parties have been working diligently and in good faith to develop a proposed procedural schedule for a Consolidated Phase hearing in each of the nine state commissions in which these and similar matters are pending.

Some details remain the subject of discussion, and while the parties are optimistic that they can reach agreement on these details, legitimate scheduling conflicts make it unlikely that these details can be resolved in time to file a proposed schedule tomorrow as anticipated.


