

Pursuant to the *Order Staying Action by AT&T Tennessee Under Notice of June 21, 2010 and Setting Status Conference for Oral Argument*, a **Status Conference** has been scheduled in the above-captioned proceeding for **Monday, July 26, 2010**, following the Authority Conference being held on that date at **1:00 p.m.** in the Hearing Room on the Ground Floor of the Offices of the Tennessee Regulatory Authority at 460 James Robertson Parkway, Nashville, Tennessee. This Status Conference is being held for the purpose of having the parties to this docket present argument as to whether AT&T's *Notice of Commencement of Treatment Pursuant to Current Interconnection Agreement* ("Notice") and the actions proposed there under should be further stayed because the issues raised by the *Notice* are intertwined with the issues in this docket and other complaint cases filed by AT&T against other telecommunications service providers that involve "substantially similar" issues.¹ All parties are entitled to be represented by counsel.
