Re: *BellSouth Telecommunications, Inc. d/b/a AT&T Southeast d/b/a AT&T Tennessee v. BLC Management, LLC d/b/a Angles Communication Solutions*, Docket No. 10-00008

Gentlemen:

On January 8, 2010, BellSouth Telecommunications, Inc. d/b/a AT&T Southeast d/b/a AT&T Tennessee ("AT&T") filed the above-styled action against BLC Management, LLC d/b/a Angles Communication Solutions ("Angles") requesting that the Tennessee Regulatory Authority ("TRA") convene a docket in order that certain billing disputes between AT&T and Angles could be resolved and correct amounts owed could be paid. Various motions have been filed by the parties in that docket, and the last filing reflected an agreement that matters in this docket would be held in abeyance pending the resolution of similar proceedings in other states within the region.

On June 28, 2011, the TRA received a letter from AT&T notifying the TRA that AT&T intends "to disconnect local resold services [to Angles] for non-payment of outstanding balances on their regional account." A copy of Paul Stinson's letter to Lisa Cooper of the TRA dated June 28, 2011 is attached. According to the letter, disconnection of services to Angles will occur on July 19, 2011.

As counsel for the parties in this docket, you are requested to provide to the TRA an explanation as to why the actions referenced in the June 28, 2011 letter are not governed by the orders of the TRA and the agreements of the parties filed in this docket and therefore would be actions in conflict with the ongoing proceeding currently before the TRA. Given the urgency of
