The Compliance Division recommends the cancellation of authority of the following company for non-payment of regulatory fees: Four Star Marketing, LLC DBA Mid-South Home Phone. Company ID#129087.

Form UD-16 ("Computation of Gross Receipts and Calculation of Inspection Fee") together with payment of the applicable inspection fee was due on or before April 1, 2015. Pursuant to Tenn. Code Ann. § 65-4-303, the annual inspection fee is based on the intrastate revenues for the previous year. Tenn. Code Ann. § 65-4-308 provides for a penalty of 10% per month, or fraction thereof, for inspection fees not received by April 1st.

The Authority sent notice, via first class mail, on February 2, 2015, advising this company of its obligation to file the Form UD-16 and pay the appropriate inspection fee.

On April 6, 2015 the Authority received a letter informing the Agency that Four Star Marketing discontinued service on May 15, 2014 and did not have the funds to cover the filing fee associated with the Statement of Gross Earnings and Computation of Inspection Fees. Please see attached.

On April 27, 2015, the Tennessee Regulatory Compliance Division sent a Notice of Cancellation, via certified mail, return receipt requested, and first class regular mail to the company advising that if it failed to respond to the certified notice by August 31, 2015, the Compliance Division will request the cancellation of its authority to conduct business in the state of Tennessee.

As evidenced above, the appropriate recourse is to terminate the company's certificate of convenience and public necessity to conduct business in the state of Tennessee as a public utility.




