Response: Yes, GTL has filed similar applications in Georgia, Hawaii, Nebraska, New York, New Hampshire and Pennsylvania.



Dear Mr. Steinhart:

On February 1, 2010, Global Tel*Link Corporation ("Global Tel") filed an application with the Georgia Public Service Commission ("Commission") seeking to participate in certain debt financing arrangements. Global Tel provides communications services that manages telecommunications to inmates of state and county departments of corrections, it also owns and operating prison payphones and public payphones. Global Tel will enter into long term and revolving credit facilities. The long term credit facilities proceeds are anticipated to refinance certain existing credit facilities at more favorable terms. The revolving credit facilities are expected to mature within six (6) years after their respective closing dates. The proceeds from the revolving credit facilities are anticipated to substantially increase the ability of Global Tel to expand its operation within Georgia, potentially fund other acquisitions and provide the financial resources necessary to compete effectively with other service providers within the state. The interest rate for the long term and revolving credit facility will be based on the current market rates. These obligations will be guaranteed by the pledging of all assets as security interest. The transaction will not affect the rates, terms and conditions under which Global Tel operates. The transaction will also be transparent to customers and not have any adverse impact.

Global Tel is certified in Georgia to provide telecommunications services pursuant to certificates of authority numbers P-006 and 5M-0094 respectively.

During its Administrative Session of February 18, 2010, the Commission considered the above-referenced item and found it to be reasonable and proper. The Commission also found that it was appropriate without the need for a hearing in this

Letter Order – Docket No. 5295 February 19, 2010 Page 1 of 2 matter. Approval of this transaction is expressly based on the representation contained in the application filed on February 1, 2010. The Commission reserves the right to later revisit this matter and issue any further orders as it may deem necessary.

Wherefore, it is

ORDERED, that the application filed by Global Tel*Link Corporation requesting authority participate in certain debt issuance financing arrangements is hereby approved.

ORDERED FURTHER, that the authority granted herein is contingent upon the approval of any other regulatory body having jurisdiction over this matter.

ORDERED FURTHER, that within 30 days of completion of the financing transaction, the Company shall file a full and complete report on the final disposition.

ORDERED FURTHER, that the Commission hereby waive a hearing in this matter.

ORDERED FURTHER, that jurisdiction over this matter is expressly retained for the purpose of entering such further order or orders, as this Commission may deem just and proper.

ORDERED FURTHER, that a motion for reconsideration, rehearing, or oral argument or any other motion shall not stay the effective date of this Order, unless otherwise ordered by the Commission.
