Global Crossing Telecommunications, Inc. ("GCTI") and Global Crossing North American Networks, Inc. ("GC NAN") (together "Petitioners") hereby seek approval of the planned *pro forma* merger of GC NAN into its affiliate GCTI. Upon consummation of the transaction, GC NAN will no longer exist and, accordingly, hereby requests cancellation of its certification effective as of the date of consummation of the merger as notified to the Regulatory Authority.

**I. THE PARTIES**

GCNAN was incorporated under the laws of the State of Delaware on September 23, 1982. Its principal office is located in New York. The company was certificated to provide interexchange long distance service in Case 95-02845 on August 23, 1995. GC NAN is a wholly owned indirect subsidiary of Global Crossing Limited, a publicly traded (NASD: GLBC) Bermuda corporation with affiliates in the United States and several other countries providing telecommunications services. GC NAN does not provide retail telecommunications services.

GCTI was incorporated under the laws of the State of Michigan on April 5, 1989. Its principal office is located in New York. GCTI was originally authorized to provide resold long distance service in Docket U-84-7325 on September 25, 1985. GCTI currently offers resold intrastate toll telecommunications services. GCTI, like GC NAN, is a wholly owned indirect subsidiary of Global Crossing Limited.

**II. THE TRANSACTION**

On or about September 30, 2010, GC NAN will be merged into GCTI. At that time, all of the assets of GC NAN will be transferred to GCTI, and GC NAN will cease to exist. Accordingly, GC NAN hereby requests cancellation of its certification and tariff effective upon the date of consummation of the merger as notified to this Regulatory Authority.

### III. CUSTOMER IMPACT

GC NAN does not provide retail service and therefore there are no customers who will be affected as a result of this transaction.


